Guidelines for Manuscript Submission

Submission method

This journal adopts online submission. Please log in to the website to register for submission (http://www.zgmfskin.net/EN/1009-1157/home). The registration information must be true. Please check the website for the processing status after submission. If there is any change in information such as mobile phone number, email or organization, address, etc., please log in to the website in time to change so that we can get in touch with you.

In order to save your time, speed up manuscript processing and shorten the publishing cycle, please read the following guidelines and check whether your article meet our requirements before submission.

Types of Contributions

The journal provides a medium for publication of articles on original medical research, including basic medicine, clinical medicine, epidemiologic study, case reports describing the diagnosis and treatment of clinically rare diseases or those of great clinical significance could also be taken into consideration.

General Requirements of Articles

- 1. Original papers describing original research of high novelty, practicality, or clinically guiding significance;
- 2. Research have never been published on other journals;
- 3. Does not involve any potential ethical problems;
- 4. Does not involve any potential conflicts of interest with other people or organizations;

Author names and affiliations

Bylines should include all those who have participated in the project research. All authors should be notified and agreed to the publication of the article on our journal. If the author affiliation entertains cooperation with any overseas research institution, a written acknowledgement by that institution indicating its agreement to the article's

publication on our journal and a statement of no conflicts of interest should be submitted.

To avoid potential disputes, the acknowledgement file should be signed by both the corresponding author and all other authors. Please download the file from our website and upload the scanned signed form in package with other compulsory files.

Manuscript Style, Structure, and Content

- 1. Font type and size: The manuscript should be organized in a small 4-point Times New Roman font for the main body and 3-point Times New Roman font in bold for the title.
- 2. Title: The title should be short and informative. Chinese titles are limited to 20 characters.
- 3. Abstract: The abstract must be structured and state the purpose, methods, results, and conclusion of the reported research. Chinese abstracts are limited to 300 characters, and English abstracts must have a minimum of 500 words.
- 4. Keywords: Three to five keywords should be supplied according to MeSH below the abstract.
- 5. Main text: Sections should be organized by Arabic numeral subheadings.

Tables: Tables should be numbered in the order in which they are mentioned in the text, and given a brief, descriptive title. Tables should be concise and exact.

Use 5-point Times New Roman font for the title, headings and body of the table. Normally, there should be no more than 4 tables in one manuscript.

- 6. Illustrations: Use 5-point Times New Roman font for the picture title and legends and small 5-point Times New Roman font for texts in figures. Please indicate the magnification factor and stanning method for micrographs.
- 7. References: The references should follow the standard reference style of the journal Please indicate references by number(s) in square brackets in line with the text and use abbreviations for journals stipulated on Medline.For example: [1] Mabuchi T, Chang TW, Quinter S, et al. Chemokine receptors in the pathogenesis and therapy of psoriasis[J]. J Dermatol Sci, 2012, 65(1):4-11.
